

OACETT's CPD Program Changes: Have Your Say - Q&A

November 14, 2024

I joined OACETT in March 2024, and became certified in September 2024. My CPD cycle will start in January 2025. However, I have been participating to CPD approved sessions, therefore I wanted to know if those credits acquired since March will be acknowledged over my upcoming cycle.

The date of the CPD activity must be taken within your 3-year cycle period to be credited to your CPD learning requirements.

I am in the process of taking technical exams as required for reclassification from C.Tech. to C.E.T. (P.Tech). What is the stance on time toward CPD during this process? Are there active hours for exam writing and passive hours for study time?

Studying for technical exams is included as a passive activity. Writing a technical exam is not a CPD eligible activity. A CPD Support Document template will need to be filled in for the study time up to a double the time of the exam or a maximum of 5 hours.

While working in some fields there is already time being spent by professionals on study to understand and implement new technologies as part of the job. Is it possible to consider this kind of effort as CPD hours?

On the job training is included as a CPD activity. Additional information would be required regarding the activity to decide if it was Active or Passive. Please contact cpd@oacett.org for additional information.

Are we going to get this presentation^

We are currently checking the status of the presentation, as soon as possible it will be available on the OACETT website.

Since 2016 I have been recording my CPD on an excel spread sheet and saving all proof of participation (certificates, registration receipts, summaries, etc.) in a folder on my pc and backed up in the cloud. I have not uploaded this information to the OACETT website, just due to the time it would take to transfer it. Is uploading this information to the OACETT site required or can I just carry on as I've been doing knowing I will have to provide this documentation should I be audited.

All CPD information for your 3 year cycle should be uploaded to the OACETT portal for auditing purposes.

When will this new program begin?

New CPD program will start January 2025

where can we see a CPD points balance....and id there a library of e-learning to draw from?

Please review your CPD portal regarding the current CPD information. Please note that each member is required to enter their information into the portal. The CPD Subcommittee will be creating an e-learning library which will be available in the first quarter of 2025.

I'm an Independent Environmental Professional and I'm wondering if operating a consulting firm can be used as CPD credits. As a business owner, I must wear all hats for a successful and operational environmental consulting business.

Some seminars do not issue CPD certificates, is that acceptable?

A CPD Support template will be provided with the guidebook and a section in the FAQs which indicates the other documentation which will be acceptable.

Will it remain a requirement for those maintaining a P.Eng. designation to continue also reporting on CPD for a CET designation with OACETT?

To maintain your OACETT designation you will need to continue to report CPD but you may be able to use the same activities as the P.Eng PEAK requirements.

if not already covered in the presentation... can the cpd program be a sliding time scale? as only one of our members that engage in annual conferences and workshops in my discipline, it would be preferred that the hundreds spent at the end of the 3 year term becomes closed and insignificant to the representation of cpds. most units on these available options are measured by hr. credits.

The Subcommittee discussed a sliding scale but it was decided that it would not be feasible as the time commitment to review is longer.

Any consideration for members with 25+ years with OACETT to not have mandatory continuing education reporting

We want our experienced members to use their knowledge to assist new members through mentoring and presentations in their expertise. The Subcommittee discussed and confirmed that all members are required to complete CPD.

As an OACETT member since 2002, C.Tech rcca since 2019, I would like to know what is required to maintain my certification.

You will be required to complete the CPD as per your cycle.

Do we need a certificate for CPD?

A certificate which is from the activity provider is not required but backup documentation is required. All CPD activities are required to have backup documentation, template is provided with the guidebook.

I am a recent Associate OACETT Member, joined in November 2024, and I am not assigned any CPD yet, will this attendance contribute towards my upcoming cycle?

An associate member is not normally required to complete CPD unless they did not certify within their 3 or 6 year deadline. CPD activities must be completed within the 3 year CPD cycle that you are assigned.

Does a Revit drafting course count for continued professional development if you are an electrical technologist?

Yes Revit Courses would count towards CPD. Depending on the activity they may count towards Active or Passive. Additional information is required please feel free to contact CPD@OACETT.org to provide additional details regarding the course.

Can we count programs in which we're the presenter/tester that includes testing as Active Learning?

If you are the presenter/tester the time spent both preparing and presenting will count towards your CPD. Additional detailed information is required to ensure that it would be considered Active learning. Please contact cpd@OACETT.org

What kind of supporting documentation would be required/accepted for volunteerism? (i.e.: acting as a board member for a technical association or volunteering at a association's event like the Canadian Foundry Association)

This item is currently being discussed with MES and a response will be published shortly.

I'm at 100% of my CPD hours. Since the requirements will change, will I have to modify my submissions?

After the information session it was discussed, and our decision was revised regarding the transition period. It has been decided that all members are to follow the new program. Every effort will be made to ensure that future audited members who are part way through their CPD period will not be disadvantaged during the transition period to the new program, for those who are currently in their CPD cycle please continue to input your CPD hours and follow the new program.

I thought I saw on the Slides that PEO/PMI CPDs/PDUs are acceptable as OACETT CPDs, is that accurate?

PEO/PMI/CPDs/PDUs are likely acceptable activities for CPD learning. Back up documentation will be required for all activities.

I am a certified water treatment plant operator and I am required to have 120 hours of training per 3 year cycle of my valid certification.

what evidence is required to demonstrate learning from a podcast?

All CPD activities including podcasts are required to have backup documentation, template is provided with the guidebook

When CPD courses/events are offered, is it possible to advertise the category the CPD will cover (i.e.. Active or Passive) to ensure the member knows which category it fails under?

CPD Courses advertised by OACETT will include the Active or Passive category. If you are unsure if a course/event is Active or Passive please contact cpd@oacett.org.

I find that a lot of CPD credits are from paid online courses that cost a lot of money, is there or can there be easier paths to get CPD credits from work related tasks or workplace training and advancement without taking those specific courses?

The CPD subcommittee discussed creating an e-learning document for the OACETT website which will include CPD activities. The e-learning library will be available in the first quarter of 2025.

What if you read a book on say management at home, how could this be counted?

Yes, reading a book is included as a passive CPD activity to a maximum of 3 hours. All CPD activities are required to have backup documentation, template is provided with the guidebook.

I'm heavily involved in Health and Safety in the workplace and regularly take quite of few training courses - where would these be covered in the new CPD categories?

Additional information is required regarding the Health and Safety activities to be used for CPD learning. Please contact cpd@oacett.org to confirm where they will be covered.

My question is can I use my water certification hours for CPD?

Can you provide examples of Active Learning CPD

Examples of Active learning are included in the guidebook which will be available by the end of 2024 or early 2025.

how would multi-day training session factor into the 30 hours? would a two-day course count for 16 hours?

All CPD activities are required to have backup documentation, template is provided with the guidebook. For a multi-day training session the certificate or documentation received from attending should indicate the hours which can be used for your CPD activity.

If my current cycle does not end till Dec 2027, when does the new CPD program apply? Please see response above.

I attended some CPD and mine started January 2025, will these CPD hours be accounted for me or it should be from January 2025 ?

The date of the CPD activity must be taken within your 3-year cycle period to be credited to your CPD learning requirements.

Regarding the no repeat in a 3-year cycle, what about annual association conferences (i.e.. OWWA, AWWA)?

Subcommittee discussed and confirmed if an annual conference has a different theme and activities, it will be considered for CPD learning event. Summary to be provided of the topics which were discussed.

If I complete a CPD eligible activity through my work and am issued a certificate of completion, but that certificate does not indicate how many hours I spent in the training course, how will we be able to prove how many hours we spent in the training course?

All CPD activities are required to have backup documentation, template is provided with the guidebook. For an at work session if the certificate or documentation received from does not include the hours please have your manager or team lead sign off on the hours.

Will the guideline provide example of activities

The Guidebook will include examples of Active and Passive activities

For conducting design reviews, can this be considered as a CPD?

Design reviews, if part of the member's employment role, are not applicable as a CPD activity.

does first cycle start for everyone 2025, second cycle for everyone start 2028, etc.?

Please see response above.

Can active learning be clarified in terms of courses. Are only accredited college, university courses with some sort of pass/fail exam certificate or would something like an online course for software count?

Active learning is interactive activities. Examples of recognized courses are provided in the guidebook

If this new CPD is rolled out in Jan 2025, what happens for people that are in the middle of a CPD cycle (ex. started in 2024)? Does the old criteria apply until that cycle has completed or do the existing activities and hours have to get converted over?

Please see response above.

Hi...it's mentioned that CPD courses cannot be duplicated within the 3 year cycle...just confirming that all of the Fireside chats etc. are considered different since they have different topics and are all good for CPD credit. Unless of course it's the exact same.

Subcommittee discussed and confirmed annual conference has a different theme and activities, it will be considered for CPD learning event. Summary to be provided of the topics which were discussed.

What happens if you don't complete the required hours within the 3yr time frame?

If you do not meet your CPD requirements in the 3 year cycle you may lose your certification and be removed from the association. Each member included in the audit has their submissions reviewed by the Registrar.

Will OACETT offer more passive CPD activities that are free? A lot of the activities OACETT offers through emails are priced very high

MES is currently working to provide both Active and Passive courses.

How many audits do you do annually?

One audit per year is completed. All members with an active CPD cycle are eligible to be included in the audit.

Is the process of submitting the CPD credential on line be the same?

The process for submitting the credentials will be the same as the previous CPD through the portal. A template is included as part of the CPD Guidebook which includes information needed for back up documentation.

Is applying for an LET with the PEO considered CPD?

The application process for any designation is not considered CPD.

As a cad manager I am often having to help out fellow co-workers with cad issues. My company has Phase and task for this to track time. Can the time be used for CPD?

Helping co-workers at your job is not considered CPD. If you are mentoring fellow co-workers and meet the mentoring criteria in the Guidebook then it may be considered CPD.

Are our membership fees sufficient for OACETT to provide at no (or nominal) charge to us, an active online learning portal - ideally one that will automatically associate our learning and apply the hours to us?

MES is currently working to provide both Active and Passive courses.

The date of the CPD activity must be taken within your 3-year cycle period to be credited to your CPD learning requirements.

alison.com is the one I use for lot of learning will that be still approved under new program?

Courses from Alison.com may be approved as CPD learning, please confirm with cpd@oacett.org

How will volunteer hours be measured?

A form will be provided with information for review

What should be minimum contribution of the hours for technical, management and leadership hours? Is other professional associations such as PMI etc. for the project management considered for the CPD?

The previous CPD categories are being replaced with active and passive CPD learning. PMI courses may be considered for CPD but additional information is required.

Trades shows can be used for CPD and how many hours can be applied

Trade shows are not included as a CPD activity.

Being an active executive in the chapter is this considered as a Active activity.

Volunteering is included as a passive CPD activity. Additional information regarding the activity is required if the activity is to be considered Active.

what qualifies as active training? what about safety training?

Guidebook provides examples of passive and active CPD activities.

I was attending the CPD activity but I didn't get the CPD certificate. I asked for but no one answered. How to deal with this kind of things

We have been working with MES regarding the certificates if participants do not attend a minimum of 1 hour they will not receive a certificate. Please contact cpd@oacett.org.

PEO/PMI/CPDs/PDUs/OAAs may be acceptable activities for CPD learning. Back up documentation will be requried for all activities.

Here is my observation/questions about CPD:

- -II wonder why we don't have more training on software on various fields? As an active job seeker (with little luck so far) I've seen many different requirements for software knowledge like all sorts of administrative, project management and CAD.
- -Mechanical Engineering seems to abandon and there are barely anything relevant to collect CPD. There is absolutely no training programs for AutoCAD and SolidWorks as two most popular software in industry. Some people, like myself, finished schools when there was no CAD yet. I do use some of them but these two are only available if somebody works in larger firm. Besides, there are lot of changes as technologies move forward.
- -ME, as a almost abandon discipline in the universe of the OACETT, would courses from other discipline like electrical, chemical and civil engineering count toward CPD? I believe all these disciplines are relevant to ME, since there is not much for ME.

No, Active courses do not need to be taken through OACETT. A minimum of 15 hours of Active CPD activity is required over a 3 year cycle.

How will you're minutes participating in a chapter meeting be logged if you're on the executive committee and how will it count towards your CPD?

Participating in chapter meeting will be passive learning and allows for up to 15 hours of passive activity.

would a safety interaction qualify?

The date of the CPD activity must be taken within your 3-year cycle period to be credited to your CPD learning requirements. If you sign up and pay for a course in December but the course is in January the activity would count towards your 2025-2027 cycle.

Will CPD certificates continue to be emailed to us when we have completed our training? Yes, certificates will be emailed by MES.

Is the CPD requirement of 30units applicable to student member as well?

No, certified members, and associate members outside of their certification window.

Do you require CPD if you retire and consult part time?

Please review the criteria for retirement OACETT membership status. If retirement status is applicable, then CPD not required.

I'm required to take interactive courses provided by my employer that are specific to my job. Would these qualify as Active Learning? The guidebook specifies Professional courses as being from recognized educational institutions only?

Audits are completed annually. One audit is held per year. The number of audits each year is dependent on staffing and discussions with the RPPC. The total number of audits increases each year as the OACETT portal has assisted with organization and auditing.

Continuous education at LinkedIn or Community Colleges are considered passive!

Linked in courses which do not include interaction are passive CPD learning. Courses which include testing and interactions are considered active CPD learning.

we have new hires in our company that are being mentored by senior employees. Mentoring initiatives are part of our job. How can we credit mentoring initiatives in CPD, and how can we credit the hours.

Mentoring documentation is included on the OACETT website, please review the requirements. Back up documents and information will be required for CPD learning.

we have monthly tailgate meeting for an hour Would this count for anything?

Networking is not considered a CPD Activity.

If you return to school part-time for an engineering Masters or PhD, can you count the coursework towards active CPD?

Yes taking part time schooling is included as CPD learning.

Are ASHRAE webinars or in-person technical training sessions considered eligible for CPD points?

Yes webinars and in person courses are eligible for hours in activities.

Do you have some example of active and passive CPD programs and/or courses?

Active and passive activity are indicated in the Guidebook

I have done some courses from Alison, Is it required to buy certificate from them or just learner verification will be enough?

A back up document template will be required if a certificate is not issued from the provider.

Would Internationally Educated Professional mentoring valid for CPD?

Mentoring documentation is included on the OACETT website, please review the requirements. Back up documents and information will be required for CPD learning.

I recently completed TM47: Stormwater Management, a 40-hour training course, and I am inquiring about its eligibility for CPD hours. Could you please confirm if a Good Roads certificate is accepted as CPD? Additionally, how many hours from this course will be considered for CPD?

Both are CPD approved. Active hours are the amount of hours in the course not including lunch or networking which are noted on the certificate.

Is a PMP course active or passive CPD? Do you need 50% of each type?

PMP courses that include testing are active learning, Active learning can be 100% of the 30 hours CPD learning, Passive learning can be up to a maximum of 15 hours.

If you are only doing self study and will take up a 3 hrs technical exam? how do you declare the hours?

Studying for technical courses or testing is included as a passive activity. A CPD Support Document template will need to be filled in for the study time up to a maximum of 5 hours.

how would you report mentoring students. As a maintenance manager I have mentored coop students for Engineering Technology courses for the last 10 years
